### TERMS AND CONDITIONS

1. The Win a Dream Holiday prize draw (the "Prize Draw") is open to UK residents aged 18 and over who provide their name, address, contact phone number and email address.
2. Employees or agencies of the Sainsbury Centre for Visual Arts ("the Sainsbury Centre"), University of East Anglia, Norwich Research Park, Norwich, NR4 7TJ or their family members, or anyone else connected with the Prize Draw may not enter the Prize Draw.
3. Entrants into the Prize Draw shall be deemed to have accepted these Terms and Conditions.
4. By submitting your personal information you agree to receive emails from the Sainsbury Centre and Mundy Cruising (see 10.) containing offers, events and exhibitions that we think may interest you. You will be given the opportunity to unsubscribe on every email that is sent.

No purchase is necessary. 7. The Sainsbury Centre accepts no responsibility for entries that are lost, delayed, misdirected or incomplete or cannot be delivered or entered for any technical or other reason. Proof of delivery of the entry is not proof of receipt by the Sainsbury Centre.
8. The closing date of the Prize Draw is 23:59 on 20 January 2017. Entries received outside this time period will not be considered.
9. One winner will be chosen from a random draw of entries received in accordance with these Terms and Conditions. The draw will be performed by a random computer process. The draw will take place on 23 January 2017.

10. The winner will receive a holiday provided by the Sainsbury Centre's exhibition partner Mundy Cruising of 50-51 Wells Street London W1T 3PP namely a cruise for two in a cabin with porthole on the MS Paul Gauguin departing Fiji 24 June 2017 on the 12 day cruise to Papeete, including all meals, drinks and gratuities, with economy class flights from London via Los Angeles (outward 23 June to be confirmed inward 7 July to be confirmed). No transfers or hotel nights are included.

The Sainsbury Centre and Mundy Cruising accept no responsibility for any costs associated with the prize and not specifically included in the prize (including, without limitation, travel to and from the departure airport, excess baggage charges, meals, fuel, car parking charges, and overnight stays).
